Dog Licenses have come to a standstill, mailed out reminders to dog owners, have had a few come in a pay after they received reminder letter.

Town Clerk asked about the bid copier, she asked if they want to keep paying for the copies, Toshiba supplies the toner, we pay for copies. It costs around \$80.00 for every 3 months. The company will not service it. The Town Board stated that we should just keep paying every three months as long as it still is working fine. This would be cheaper than getting a new one. It does not get used a lot.

#### Highway Superintendent: Alex Hodge:

#### **General Repair:**

One truck is at Stadium International

Need to take the other truck up, it will cost \$8,000

The truck that was just fixed needs to go back to Stadium International

#### Other:

Closing Billings Hill Rd down to put the culvert pipe in.

Alex stated that he feels the wages need to go up for highway, other towns are raising their wages to keep the employees they have. Chenango County Highway are losing a few of their employees, they are going other places to work for more money.

Alex suggested raising it to \$25.00 per hour for all year and take away the \$2.50 per hour for plowing. This would be a 20% increase in pay. The Town Board will take it into consideration.

Council Marie Morgan asked Alex if other towns employees must pay for their health insurance, He stated yes. The town of Lebanon pays 100% of the health insurance for the highway employees.

Council Chadwick Nower asked about the highway employees would be willing to pay for half their health insurance. That would save the town money.

This will be discussed when its time to do the budget.
