Discussion:

Code Enforcement Officer Aaron Camp presented a new updated building permit application.

It is four pages long compared to the twelve page long old one.

Town Clerk Joann Collins stated that when residents come in to get an application and she hands it to them they complain how long it is. The new is much simpler.

The Town Council members stated that there will be resolution for the next meeting to change the application. They thought it was a clever idea to change it.

Aaron discussed about changing the rates for permits and the Town Council agreed.

Aaron will go over the rates and update them and present this to the Town Council. Aaron also stated that the Town should charge for extra trips for inspections, he sometimes must do several inspections and the Town does not charge for this and he feels they should, He checked with other towns, and they do charge. The Town Council agreed they need to update the rates and charges.

Council Greg Fuller discussed issues with SOMAC, about whether should request an audit, the Town Board members agreed they should.

There was a discussion on the Town getting an ambulance service and a Fire Department. The Town pays out a lot of money for this and they think it would make more sense to have our own. Highway Superintendent Alex Hodge stated that they could use the Highway cold storage building for this.

There is much needed research that needs to be done on this, also The Town Council wants to check for grants for funding.

All the Town Council think this a great idea to research this.
