DISCUSSION ITEMS:

Councilor Marie Morgan gave the results of the town officials audits; she gave copies to each official that was audited and then she gave a report. The Town Clerk's audit was good with no issues, The Supervisor's audit was fine, but the audit committee has some recommendations which were to deposit checks within 72 hours. The Justice audit was good with no issues.

Discussion was made about the Generator; it has never worked properly since it was installed.

Jamie stated that Generac came in and put a block heater on, but the generator still does not work, it will not even run.

Deputy Supervisor Adam Carvell stated that the town needs to send a letter to Buell Fuel Hearth & Home. He commented that he would draft this letter and present it to the Supervisor. This letter will need to be sent by certified mail with an explanation.

Deputy Supervisor Adam Carvell commented that it would cost the town to get the Town Attorney involved but we really do not have a choice, we need the generator.

Councilor Chadwick Nower had stated that he contacted Buell Hearth & Home about this, they had not got back to him on this yet. When he finds anything out, he will let everyone know.
