Whereas the Town of Lebanon Town Board wishes to grant the following pay bonuses to the following employees who worked without a pay increase in 2021 and who are recognized by the Town as going above and beyond during the Covid 19 pandemic to provide essential services to the town.

**Now Therefore Be It Resolved; the** Lebanon Town Board approves the following one time pay bonuses using ARPA funds for the following positions in 2021 which are equivalent to 3 percent pay raises for 2021:

- Town Highway Superintendent: \$ 1,810.92

Increase A 1670.4 from \$1,300 to \$1,600

Increase A 1410.4D from \$300 to \$600

Decrease A 1990.4 from \$652 to \$352

Decrease A 1410.4 F from \$500 to \$200

#### 2021 Highway Fund

Transfer \$8,000 from DA 5110.4M9 General Repairs Contractual to DA 5110.4K, General Repairs, Supplies

Increase DA 5110.4K from \$28,000 to \$36,000

Decrease DA 5110.4M9 from \$70,000 to \$62,000

Transfer \$5,000 from DA 9060.8, Health Insurance to DA 5130.4J4, Outside Services

Increase DA 5130.4J4 to \$25,000

Decrease DA 9060.8 to \$26,000

Transfer \$6,500 each from DA 5142.1, Snow Removal, PS and DA 5148.1, Other Govt PS to DA 5110.1 General Repair, PS

Increase General Repairs, PA from \$81,000 to \$94,000

Reduce DA 5142.1 and DA 5148.1 from \$66,000 to \$59,500 each.
