Section 1. A person is guilty of exposure if he or she appears in a public place in such a manner that the private or intimate parts of his or her body are unclothed or exposed. For purposes of this section, the private or intimate parts of a female person shall include that portion of the breast which is below the top of the areola. This section shall not apply to the breastfeeding of infants.

Section 2. Exposure of a person is a violation.

Section 3. This Local Law is enacted pursuant to New York Penal Law Section 245.01.

Section 4. This local law shall take effect upon filing with the Secretary of State.
