Safety Committee chair Patricia Matson had asked David Craine about if he knew if there was another company for an alarm system. As we must upgrade ours. Our current company will not get back to us. He stated that he will check with other municipality entities around. He would get some references for us.

Supervisor Goldstein asked Brynley what other towns are doing regarding the ARPA funding, she said that they are finding they start out with a high number and then they do not qualify for the things that the towns must do to get this money and the figure comes way down.
