- Section 1. The term of office of elective Town Clerk for the Town of Lebanon shall be four years. Such four year term shall commence on the first day of January 2002.
- Section 2. This local law shall supersede in its application to the Town of Lebanon Section 24 of the Town Law with respect to the term of office of the elective Town Clerk.
- Section 3. This local law shall be submitted for approval to the electors of the Town of Lebanon at the general town election to be held on November 6, 2001.
- Section 4. Any other local law, ordinance or resolution inconsistent herewith is hereby repealed.
- Section 5. This local law shall take effect immediately upon filing with the Secretary of State after approval by a majority of the electors voting thereon in accordance with the requirements of Section 27 of the Municipal Home Rule Law.

5. (City local law concerning Charter revision proposed by petition.)
