**A LOCAL LAW TO ESTABLISH THE FIRST MONDAY AFTER THE FOURTH
TUESDAY IN MAY AS THE PERMANENT GRIEVANCE DAY FOR THE
TOWN OF LEBANON**

Be it enacted by the Town Board of the Town of Lebanon, as follows:

Section 1. AUTHORITY.

This Local Law is adopted pursuant to Section 512 of the New York State Real Property Tax Law.

Section 2. PURPOSE.

It is the purpose of this Local Law to establish the first Monday after the fourth Tuesday in May as the Permanent Grievance Day for the Town of Lebanon.

Section 3. DATE OF TRANSITION.

The 2003 Grievance Day shall be held on the first Monday after the fourth Tuesday in May and each Grievance Day thereafter shall be held on the first Monday after the fourth Tuesday in May until this Local Law is rescinded or superseded by subsequent Local Law.

Section 4. EFFECTIVE DATE.

This Local Law shall become effective immediately upon filing in the office of the Secretary of State.
