Whereas, the Town of Lebanon own Board has the final authority over all matters financial, and

Whereas, the Town Highway Superintendent is requesting to add full time 40 hour per week year- round Motor Equipment Operator position due to difficulty finding seasonal full time MEO" S to work to plow the Bradley Brook Rd corridor for Madison County, and

**Whereas** the Town Highway Superintendent also requests the additional position due to safety considerations during construction season,

Whereas the Town Supervisor estimates the additional expense including all the necessary fringe benefits, health insurance and workers comp/ state retirement and overtime could add an additional \$ 40,000 to the town budget. NOW THEREFORE BE IT RESOLVED, the Town of Lebanon Town Board authorizes the Town Highway Superintendent to create, fill and hire an additional year-round MEO position for the Town of Lebanon at a starting pay of \$ 19.85 per hour non/winter rate.
