Section 1. The purpose of this local law is to adopt the Cold War Veterans Property Tax Exemption and set a basic 10% assessment reduction, capped at \$8,000, for military service and one-half their service connected disability rating, capped at \$40,000, as authorized by Section 458-b of the Real Property Tax Law.

Section 2. Pursuant to Section 458-b of the Real Property Tax Law of the State of New York, the Town hereby adopts this Local Law of the Town of Lebanon, granting the Cold War Veterans Exemption.

Section 3. Pursuant to Section 458-b of the Real Property Tax Law, the Town hereby sets the basic 10% exemption capped at \$8,000 allowable for active duty service between September 2, 1945 and December 26, 1991, who do not currently receive either the eligible funds or alternative veterans' exemption.

Section 4. Pursuant to Section 458-b of the Real Property Tax Law, the Town hereby sets the additional exemption for disabled veterans at one-half their service connected disability rating, capped at \$40,000.

Section 5. This Local Law shall take effect immediately upon filing with the Office of the Secretary of State and shall apply to the taxation of real property by the Town of Lebanon after December 31, 2009.
