Busy cutting shoulders and digging ditches

The truck is still in Syracuse it needs a new head.

Alex and Brynley will do the chips in September.

Alex stated that if he orders a new truck now the price is good for 3 years. It locks it in, (state bid price). Supervisor Goldstein will check with the lawyer to make sure we can do this.

Alex stated that we have two trucks with the (bad motor) a 2015 & 2016.

These two trucks are due for replacement in 2025 and 2026.

Alex stated that he got a quote for the painting of the Town barn/Office building. This is for the roof and sidewalls. This will preserve the Highway garage and Town Office building for at least 20 years to reduce future replacement and pother building expenditures. This is the only one he got, everyone else are busy and can't do the job. The quote is for \$ 25,700. That is to pressure wash, prep, clean, paint, finish. This money will come from the ARPA fund that we received.

ON THE MOTION OF COUNCIL ADAM CARVELL AND SECONDED BY COUNCIL PATRICIA MATSON

To have Alex contact the person to paint and order the paint and do the project. There will be a down payment of \$15,000. Which will be issued when Alex orders the paint.

Alex discussed about upgrading the generator to a propane unit due to all the power outages the town has been experiencing and the impact the surges have been on the town operations and the highway overhead doors. The propane generator would automatically come on whenever there is an outage. The gas generator we have now, the highway must come and set it up when there is an outage.

Use of ARPA fund will save the taxpayers a lot of money, The town had an emergency expenditure for \$66,000 to replace the Cold storage for the highway equipment as it was collapsing in., this project is not eligible for the ARPA funds, and it was done before March 21, 2021.

Town Supervisor: James Goldstein: Present

Discussed Financials

Supervisor Goldstein stated that the COVID cases have started to raise.

CDC added Madison County to wear masks in doors & outdoors to their list.

Town Officials discussed the use for approximately \$ 132,000 in American recovery Act Funding (ARPA it has now determined it is eligible to spend on government activities now that the consultants retained reviewed the town's budgets since 2019 and have determined that the town is eligible to utilize and receive the funds. Lebanon received the first payment of approximately \$ 66,000 in late July after agreeing to accept the funds and evaluate eligibility. The town had the option to return the funds if it determined it was not eligible for them or to transfer them to Madison County for use.

Supervisor Goldstein reported on his meeting with the consultants from the Bonadio group which had been retained by the town to determine eligibility who had reviewed the 2019,2020, 2021 town budgets and had determined that based on town revenues and the formula established by the ARPA the town qualified to spend the funds on any government activity from March of 2021 on and only items it could spend the funds on were debt repayment, tax reduction, matching funds for state or federal grants, judgements or claims or increased contribution

to pension plans. The town has no judgements or claims and only contributes to pension plans that are part of the NYS retirement system that are predetermined by the state and budgeted for annually for those employees who participate.
