**WHEREAS**, the Town of Lebanon is charged with the repsonsibility of appointing residents to the town Assessment Board of Review and,


Whereas there has been a vacancy on the Assessment Board of review since Sept of 2021.

#### **RESOLUTION # 40-22 ESTABLISHING LEBANON CLEANUP DAY FOR APRIL 30,2022**

**Whereas**, the Town Board's wishes to provide spring services for residents associated with Madison County's annual Cleanup Day program

**Now Therefore Be It Resolved that**, the Lebanon Town Board Members authorize the following actions regarding Lebanon Cleanup Day:

- 1. Residents muct comply with all Madion County landfill guidelines on prices and items brought to the Town Highway Garage
- 2. That the Town Highway Department will supervise thedis[posal or recyling of all eligible items.
- 3. That each towen resident may turn in two plastic garbage bags of roadside trash that they have gathered along with one furniture item at no charge.
- 4. That all recyclables accepted by Madison County landfill guidelines.
- 5. That all paid items come to the Town Clerks external window betweeeb the hours of 8:00 am to noon.

## Discussion:

Supervisor Ronda Winn stated that Madison County has the harvester for lakes that they no longer are going to use, and Alex Hodge stated he thought that Lebanon could use it for Lebanon Reservoir, Lois Hartshorn stated that they contact the lake association president on this.

There will be a meeting on April 13, 2022, with spray foam insulation on the cost of insulating the town offices and highway garage. This will be for the grant for which we are applying.

It was suggested to stop doing zoom at the Town Board meetings. It was discussed and the option will be that if a board member cannot attend a meeting, they will contact the supervisor and she will do a zoom link and they can attend that way. All Board Members agreed. 4 Ayes 0 Nays 1 absent.

Town Clerk Joann Collins mentioned the cost of the website that Digital Towpath charges it is up to \$900 per year. Supervisor Ronda Winn asked Aaron Camp if his son could create a website for the town and Aaron said yes. The Town Board agreed to this.

Supervisor Ronda Winn suggested to have a scrap metal company owner by Ben Whitesman bring in a dumpster to collect junk metal from residents. Have this done after cleanup day. This would be a way for residents to clean up their yards.

Council Adam Carvell stated that he talked with Amish, but it was with the younger ones. He has noticed that they are using lights a little more.
